5 - FIRE-FIGHTING MEASURES

Appropriate: carbon dioxide (CO₂), foam, water mist and powder. Extinguishing media:

Inappropriate: water directly onto the burning material.

Specific hazards arising from the chemical:

Combustion of the material or its packaging can form irritating and toxic gases such as carbon monoxide and dioxide.

Very dangerous when exposed to excessive heat or other sources of ignition such as: sparks, open flames or flames from matches and cigarettes, welding operations, pilot lights and electric motors. May build up static charge by flow or agitation. Vapors from heated product can ignite by static discharge.
